*Europe"* project is an **UrbanHist** work package developed by Instituto Universitario de Urbanística of University of Valladolid as host institution. It aims to analyse the historical and conceptual origins of urban practice in 20th Century in Europe, in order to discuss the historical common base of a specifically European urbanism in the 20th Century. To this end, the research on the origins and evolution of some of the main contents of urbanism developed in Europe along 20th Century is proposed. Meanings and values assigned to these contents will be analysed from specialised discourses (mainly urban discourses, but also economic-social, politic and other ones) and from the most significant practices on planning, as well as from the relationship of all of them with urban and historical contexts of reference.

"Heritage and Urbanism in Europe" is one of the two fields involved in the work package "Hundred years expanding tasks". It will research the history of wide-spread processes of 'heritagization' in relation to the urban policies and planning focusing recognized values of the existing urban spaces and landscapes in European cities. This task will address a comparative reading along the European countries in order to construct a European scale approach to this issue.

# Co-supervison: Blekinge Tekniska Högskola (Sweden)

The objectives of this thesis are, in first place and with a comparative method, to expose the evolution of planning concepts and tools for urban preservation in several European Countries (the concrete countries must be selected), second to investigate how landscape is interpreted by European urbanism related with the historic cities and, third, to inquire into the European urban

culture about the evolution of ideas related with the historic city preservation and about the consolidation of common concepts, principles and practices in this issue. We expect to develop a coherent research on the proposed issue, at least related with four European countries, with the capacity of clarifying the historical evolution and meaning of urban concepts usually performed without criticism. A new history of urbanism for historic cities and towns in Europe could, with an effort of comparative research, improve the conceptual basis and targets of future planning actions. This task will boost the historical research on the discursive and the practical relations in early 20th Century Europe among urban problems, public action and urbanism, particularly focusing on two very important fields for the construction of contemporary European cities as for the origin of urbanism: housing and infrastructure. Furthermore this task will bring added value to the previous researches in these fields at national scale.

## What we offer:

You are eligible to apply for the positions UVA 2.1. or UVA 2.2 if you fulfil the following preconditions:

- Master degree or equivalent based on studies with minimum 300 ECTS in the fields of planning, architecture, history, geography, urban sociology, landscape architecture or other relevant disciplines. This master degree or equivalent has to be from an EHEA (European Higher Education Area) country, or, if awarded from a non-EHEA country, it has to be homologated.
- you are in an early stage of research career, which means within the first four years (fulltime equivalent) of research activity, including the period of research training and you are not already holding a doctoral degree (<u>http://ec.europa.eu/euraxess/index.cfm/rights/definitions</u>)
- following the transnational mobility rule, you must not have resided or carried out your main activity (work, studies, etc.) in Spain for more than 12 months in the 3 years immediately before the reference date
