ISOCARP REGULATION 2021/04

Introduction

This policy paper explores ISOCARP's existing and potential partnerships with other organisations of different kind, including those in which we are accredited, represented or gained membership. Endorsement of events conducted by other organisations will be treated as part of the informal-formal partnership spectrum.

ISOCARP has a unique position as a planning professional INGO open to individual and institutional membership from all over the world, while ISOCARP Institute is establishing itself as partner for project-related clients all over the world. There are many other professional organizations within and outside the urban and regional planning community to relate to and eventually to develop partnerships and/or projects with. Existing partnerships need to be reviewed while new partnerships might be considered, including a few formal.

Under the ISOCARP Presidency of Ric Stephens, ISOCARP developed and published the unique and comprehensive <u>International Planning Organisations Database</u>, compiled by the University of Oregon, USA. This database includes urban and regional planning agencies, associations, institutes, ministries, societies and universities. The database needs more regular update and does not provide guidance on relevant partnerships for and with ISOCARP Society.

To that purpose, the ISOCARP Board established an initial list entitled 'Survey partnerships ISOCARP 2018'. Partners were listed in alphabetical order, but the 'survey' needs to be reviewed and held against the more comprehensive database. Annex 1 displays is a simplified table with extended potential partners and proposed priority & action. The list needs to be further completed by the ISOCARP Board Team Partnerships & Endorsements – to be approved by the Board.

As the ISOCARP Institute is operating projects and activities in cooperation with partners globally, the survey is also including Institute project partners. The partners of ISOCARP Institute are related to the three pillars of activities: Institute Academy, Institute Research and Institute Practice. As an example, the research branch of the Institute is partnering with several project partners within EU research projects. Institute Academy is partnering with institutions such as universities, and Institute Practice includes partners in the field of technical assistance. ISOCARP Project partners are listed in Annex 2.

This categorization reveals a potential overlap with our Institutional Members. Conversely the list could also include organizations that could be targeted as potential Institutional Members. This stream needs to be coordinated with the Board Team on Members.

Listed philanthropic organizations are as such not engaged in urban and territorial planning, but they are potential sponsors of planning organizations and activities. They need a special kind of outreach.

This list also contains a selection of recurrent 'planning events' where ISOCARP might want to be present or engaged in.

Most critical however is to define or redefine ISOCARP's position and strategy vis-à-vis these organizations, including our current accreditations, memberships as well a concurrent endorsement policy.





State of Play 2021

Only by considering the long list of potential partners, we are clearly operating in a very complex and competitive field of players. Certainly, compared to the early years of ISOCARP, the playing field of organisations dealing with urban and territorial development has grown exponentially, spurred by a combination of ongoing globalization, increased multilateralism and of course humanity's call for a global sustainable development agenda. For a relatively small and under resourced player as ISOCARP, it became increasingly difficult to stand out and raise the voice of city and regional planners.

However, thanks to the relentless efforts of generations of volunteers, ISOCARP actually gained recognition and respect above its nominal weight. This is demonstrated by our 10-yearlong partnership with UN-Habitat which was entirely renewed last year for another 10 years – coinciding with the Decade of Action to implement the SDG Agenda 2030. The renewed Memorandum of Understanding (MoU) with UN-Habitat is currently complemented by an operational workplan, already resulting in, a.o., a reconfirmed partnership of the World Urban Campaign, collaboration to advance International Planning Guidelines and – most recently – the co-hosting of our first virtual World Planning Congress. Combined with ISOCARP's related active role in Habitat Professionals Forum, this already represents a workstream that exceeds by far the 'after hours' engagement of voluntary Board members.

Also in 2020, as a spin-off of reinvigorated collaboration with UN-Habitat, ISOCARP was introduced to the relatively young organization Urban Economy Forum, resulting in not only another MoU and co-hosting our virtual congress, but also in a 5-year platinum institutional membership arrangement and a conditioned donation to help us helping them.

Meanwhile, as a follow up on our active-engagement campaign in the 9th World Urban Forum in 2020, we also re-invested in collaborative action within the Global Planners Network, representing the entire planning community. This not only resulted in a full (free of cost) ISOCARP membership of GPN, but also in a collaborative effort of RTPI – the largest planning organisation in the world - and ISOCARP to co-draft GPN's World Town Planning Day Statement, presented by the then RTPI President at the opening ceremony of our virtual World Planning Congress. Consequently, the newly elected RTPI President supported our Cyber Agora event on Women in Planning, with a video message announcing her 3-year individual membership and reaching a hand to explore further partnership.

Adding the time and effort invested in other old and new (formal and informal) partnerships such as P4CA, ISUH – both resulting in two different Urban Thinkers Campuses, MTPA – resulting in a joint networking event at WUF9, GPEAN – resulting in a joint Planning Education Session, OECD – resulting in s stream of ISOCARP contribution and joint sessions, SACPLAN – resulting in a joint pre-WTPD seminar, METREX/VDM – stemming from a joint Eurodelta Session, ECTP and NIUA, makes the glass look (more than) half full rather than half empty. Certainly, when we also add the 2020 new partnership with Planning Aid Scotland, resulting in a new joint platform called 'Global Planning Aid' – aiming at advocating and enabling planning rights for deprived communities in both Global South and North.

Yet, a more pessimist or realist perception is also legitimate. Scanning the longlist of partnerships in Annex 1 and 2, we only cover a minority of the potential partnerships. Even after applying strict selection criteria, we will retain more interesting partnerships than we reasonably can handle within our currently available human and financial resources. That means that we need a very strategic approach to sift and select the most relevant partnerships, both through formal and informal collaboration. As informal collaboration is actually driven by ad-hoc opportunities (including endorsements), this is the least to worry about, as long as they do not distract or sap critical energy away from essential formal partnerships. However, even adhoc informal partnerships need to be guided by a basic partnership strategy. Also part of the more pessimistic 'half-empty' perception is that most of our representations — e.g. in ECOSOC, UNECE and UNESCO have not been closely monitored and that most Board members, let alone ordinary members have actually no idea what these representations mean and (can) do for our Society or Institute. Hence the need for a comprehensive strategy on both partnerships and accreditations/representations.





Partnership Strategy 2021-2023

Although partnerships indeed often happen on an ad-hoc basis – e.g. to co-implement a joint event, ISOCARP Board needs to establish a strategy to prioritize, materialize and maintain partnerships, taking into account the very limited human and financial resources at hand as a member-based non-profit organization.

The partnership strategy will contribute to and enshrined within the overall Strategic and Financial Planning outlined by the Board – currently for the period 2021-2023. The partnership strategy needs to be aligned with the overall vision and mission of the Association and its Institute Foundation – hence it will need to contribute achieving the higher goal of well-planned sustainable city- and regional development through multilevel and multistakeholder collaboration and citizen participation.

Derived from our Strategic Plan 2021-2023, the following six guiding principles can help us to navigate in the forest of partnerships:

- We consider 'ISOCARP' as the combined ecosystem of the Society and its Institute. All formal partnership agreements (including representations and endorsements) are managed by the Board of the Society, while the Institute is entitled to engage with project-specific partners.
- Guided by our Vision & Mission: contributing to the SDGs, New Urban Agenda and beyond through recognition of the
 critical role of planning and planners. We do not partner with political organisations, nor with organisations that do
 not contribute to the sustainable development agenda and related human rights.
- 3. **Value** for and by ISOCARP Members. Value for the members means that we prioritize partnerships that can result in meaningful collaboration related to our own or their activities and events accessible for our members. Conversely, members can also ad value to partnerships by directly engaging in co-productive partnerships.
- 4. **Learning** form the past. That means that 'old' partnerships need to be scrutinized in the context of today and what they offer for the future. We cannot rely on 'automatic pilot'.
- 5. 'Affordable' in terms of available resources. This is not easy to anticipate but as a thumb of rule we should avoid paying membership and registration fees, unless there is measurable 'return on investment'. The available human resources do not need to be limited to Board members, but the Board is overall responsible for managing and monitoring the partnerships. Representations of the Board by ordinary or staff members need to be well regulated and coached.
- 6. The most preferred form of partnership is through **institutional membership** of the Society, eventually combined with a Memorandum of Understanding or similar formal partnership-agreement. The Board might consider enabling incentives, e.g. by offering a yearlong free membership trial.

At a more operational level, the Partnership Strategy suggests five qualifiers to sift essential from non-essential partnerships:

- 1. Advocating planning and planning professionals as part of the sustainable agenda. This is linked to the second guiding principle and is absolutely key.
- 2. **Sharing planning knowledge and inspiring planning practices**. This is linked to the third guiding principle and requires a cross-over approach between Society and Institute.
- 3. **Generating joint planning activities and services**. This is also related to primarily the third guiding principle and equally requires a cross-over approach between Society (focused on planning activities) and Institute (focused on planning services).
- 4. **Enabling fundraising (Society) and project-funding (Foundation)**. This is primarily linked with the fifth guiding principle and is considered as a top priority for the financial sustainability of both the Society and the Institute.
- 5. **Mobilizing new institutional and individual members**. This is primarily linked with the sixth guiding principle and is considered as a top priority to increase the overall membership volume of the Society.





Derived from the International Planning Organisations Database and the more recent ISOCARP Strategic Position Paper 2021-2023, following partnership categories are considered:

- 1. Accreditations & representations
- 2. International planning associations
- 3. International planning institutions
- 4. International urban/planning research organisations & institutions
- 5. International urban/planning consultancies & corporations
- 6. International planning relevant organisations
- 7. International development organisations
- 8. International urban media & publishers
- 9. National planning organisations & institutions
- 10. Cities & urban planning agencies
- 11. International charitable & philanthropic foundations
- 12. Corporations & companies
- 13. Urban/planning event organisations

Annex 1 contains a draft listing of existing and potential partners for each of these categories, while Annex 2 adds project partnerships generated by the Institute, of which some could eventually be complemented by partnership agreements or institutional membership of the Society.

For reason of simplicity and strategic prioritization, the table below suggests possible priorities for short-medium or even long-term partnerships. The partners which whom we already established an MoU are in blue font – <u>underlined</u> if it is a recently established MoU (less than 2 years old) or a recent registration as institutional member; and *italic* when there is a workplan (in the making) to implement the MoU. The few accreditations we have are in red font. The potential partners to aim for by 2023 are in green font.

However, making use of the five qualifiers, this matrix can be reshuffled in a 'opportunistic' classification of partners:

- 1. Partners of global importance for our standing
- 2. Partners in support of our vision and policies
- 3. Partners to jointly provide content
- 4. Partners for project acquisition and fund-raising (Society only)
- 5. Partners to support our regionalization policy
- 6. Partners to support us financially

Applying the guiding principles and qualifiers results in the suggested table below, only showing the most critical partners to establish formal partnerships and/or maintain accreditations and representations.

This suggested selection will be more manageable than the previous table, let alone the longlist. However, it is recommendable to keep updating the longlist as new players might emerge or disqualified partners might recover.

Among the accredited partnerships, only Council of Europe (CoE) is no longer considered as essential to achieve our vision and mission. For the last 10 or more years, our representation (through paid membership of a third-party managing the INGO databate of CoE) has not resulted in meaningful results for the Society and its members, while the Council did not publish on (pan-European) spatial planning for the last 20 years. As the United Nations Economic Commission for Europe (UNECE), to which we also are accredited, also covers the pan-European area, combined with USA/Canada, this partnership should suffice to cater for our regionalization strategy - ideally complemented with similar accreditations to the other four regional commissions of the United Nations (ECA/ESCAP/SCLAC/ESCWA). Optionally we can still follow the CoE through our sister-organisation IFHP, and informal collaboration of ISOCARP and CoE remains possible. Concurrently, we need to better understand the role and activities of the European Union with regard to its Territorial Agenda and the European Green Deal, without aspiring formal partnerships with EU-Institutions, but tapping into the potentials for EU-funded planning and research projects, through e.g. Horizon Europe and ESPON, acquired and implemented by ISOCARP Institute.

For all formal partners suggested in the second table, a term of reference is required, as well the assignment of focal points in the Society ecosystem (Society, Institute and Secretariat) – as suggested in the table below.

<u>UN-Habitat</u>	The Nairobi-based United Nations Human Settlements Programme (UN-Habitat) is the United Nations programme for human settlements and sustainable urban development. It was established in 1978 as an outcome of the first United Nations Conference on Human Settlements and Sustainable Urban Development held in Vancouver, Canada, in 1976. Our 10-year old MoU with UN-Habitat was in 2020 entirely renewed for another 10 years, concurring with the Decade of Action. The UN-Habitat MoU-Workplan needs our full attention as our key partner on territorial policy and content generation. Main fields of collaboration entail our continued partnership within World Urban Campaign (WUC), HPF (see higher) and Planners for Climate Action (P4CA), as well activities related to the Implementation of New Urban Agenda and International Guidelines on Urban and Territorial Planning. ISOCARP will contribute to the Innovate4Cities conference (Oct 2021) — co-hosted by the Global Covenant of Mayors and the 11th World Urban Forum (June 2022). In 2020, ISOCARP and PAS signed a MoU and PAS co-organized with ISOCARP a WUF10 Networking Event on citizen-led planning, resulting in the joint establishment of Global Planning Aid (GPA), mainly as a platform to train 'barefoot' planners and placemakers. The UNECE Committee on Urban Development , Housing and Land Management, established in 1947, is the only intergovernmental body addressing the housing and urban development challenges of the UNECE region and the highest policymaking body of UNECE in housing, urban development and land management. Our partnership with and representation at UNECE need to be reviewed, in conjunction with the United Nations Office at Geneva (UNOG), one of the four major offices of the United Nations where numerous different UN agencies have a joint presence. Moreover, as part of our intended 'regionalisation policy', we might consider similar partnerships with and representations at the other regional UN commissions (ECA, ESCAP, ECLAC and ESCWA). In 2020, NIUA and ISOCARP signed a MoU, recommended by ISOCARP Institute as potential partner for project development. Regional Development Banks	The term 'Regional Development Banks' (RDB) usually refers to four institutions: African Development Bank (AfDB) Asian Development Bank (ADB) European Bank for Reconstruction and Development (EBRD) Inter-American Development Bank (IDB). A targeted Board action to approach one or more RDB's (and AfDB/ADB in particular) is not only needed for additional project-funding, but also plays into the intended regionalization policy of ISOCARP. Wikipedia publishes a <u>list</u> of wealthiest charitable nonprofit foundations worldwide. While the list of foundations with interest in city and regional planning is much shorter, it remains a challenge to select and focus. The Board Team Partnership will need to further investigate which organisations could be best approached for which kind of projects in which part of the world (Global South/North).	Team Partnerships

With this shortlist of most strategic partnerships we will have our hands more than full already. Based on a Partnership Policy Regulation adopted by the Board, the Board Team Partnerships will monitor the implementation of this partnership strategy. Formal partnerships and representations do not exclude informal partnerships, provided their complementarity in collaborative action and available human resources.

Endorsements are considered a special form of even-related partnerships, regulated through our standard endorsement agreement. This new partnership strategy provides a set of guiding principles and criteria to endorse third party planning events and activities.

As this Partnership Strategy is subject to a very dynamic playing field, the Board Partnership Team will review it on a yearly basis.
